# Description/Analysis

**Issue Detail:** A cursory review of the City Councils in 8 major cities across the nation (New York, Boston, Philadelphia, Washington DC, Miami, Dallas, Chicago, Los Angeles) revealed that none have a youth advisory position, held by an individual who is 18-24 years old, to their legislative body. In the Sacramento region, the only governing bodies that have a seated youth member, generally a high school student, are the school districts. Four of the 7 districts serving Sacramento youth have student members on their Boards of Education.

Councilmember Jay Schenirer hereby seeks to create a position that will further elevate the voice of the City's youth by providing a high profile, transparent, and direct channel between youth and the City Council.

Policy Considerations: The National League of Cities (NLC) has worked with local governments to

engage young people intentionally and authentically in public policy, planning, and decision-making. Through this work, the NLC found that, when civic leaders and elected officials intentionally engage youth in their communities, young people's participation, and their encouragement of peers to do the same, increases. Moreover, the NLC has observed the following benefits resulting from meaningful and authentic youth engagement:

- Budget savings and revenue generation;
- Increased support for city initiatives;
- Improved policies and programs for youth;
- Identification as a youth-friendly community; and
- Improved indicators of well-being among youth.

It is in the City's interest to recognize that youth are an important part of its systems and communities and that youth perspectives will lend new understanding of the intimate aspects of proposed policies. Although the City has the Sacramento Youth Commission (SYC) in place, not all issues that ultimately reach the City Council that have an impact on youth are reviewed by the SYC. The creation of the Youth Advisory Liaison, held by an individual under the age of 24, institutionalizes the ability of City Council to better understand how proposed policies impact its young people and the future adult citizens of the City.

To demonstrate the City's commitment to the engagement of youth voice at a significant policymaking level and to recognize the benefits of doing so, a Resolution for the Creation of Youth Advisory Liaison to the City Council (Resolution) will be considered by the City Council for approval. The Resolution provides that the Youth Advisory Liaison will:

- Attend regularly scheduled City Council meetings, except closed sessions or quasi-judicial proceedings, to be available to City Council to provide advice on any matters relating to youth;
- Have a designated seat at the dais;
- Receive the City Council agenda at the same time such material is provided to Councilmembers; and
- Be invited to attend staff briefings offered to Councilmembers, except those briefings relating to closed session, quasi-judicial proceedings, personnel or labor matters, or any matters that are otherwise privileged.

The Youth Advisory Liaison will also present a report to the Sacramento Youth Commission, on matters presented to City Council related to youth, no less than once per calendar year or more frequently if necessary.

To ensure the success of the Youth Advisory Liaison, City staff will review and make recommendations to the City Council regarding potential staffing support for, and a stipend to, the Youth Advisory Liaison.

The selection of the Youth Advisory Liaison will be similar to the process for selecting City commissioners and will include a role for the Sacramento Youth Commission. Applicants for the Youth Advisory Liaison position must be between the ages of 18-24 at the time of appointment and have experience with at least one of the following criteria:

- Participating in a youth leadership program sponsored by the City of Sacramento, the County of Sacramento or a Joint Powers Authority located within the County of Sacramento;
- Participating in a leadership skill-building program, through a multi-session curriculum, presented by a community-based organization located within the City of Sacramento; or
- Attending and making public comment at a minimum of 3 Sacramento Youth Commission or 3 Sacramento City Council meetings, within the 12 months prior to appointment.

**Commission/Committee Action:** On November 15, 2022, the City Council directed the Sacramento Youth Commission (SYC) to review a proposal for a youth advisory position on the City Council and report back to the City Council with their feedback and recommendations. Since that directive from City Council, a Resolution based on the prior proposal for the creation of a Youth Advisory Liaison to the City Council has been drafted. The SYC has been directed to review the proposed position and provide feedback to the City Council.

**Rationale for Recommendation:** Creating a Youth Advisory Liaison to the City Council is in the City's long-term interest. By deepening the engagement of young people in the City's policymaking, the City is creating a new cadre of civic leaders. Moreover, there are multiple benefits documented by the NLC that result when youth are intentionally and authentically engaged in a locality's policymaking and planning efforts.

**Financial Considerations:** It is anticipated that the proposed position will be associated with expenditures in the form of a stipend and/or training allowance and potential staffing support as staff continue to review these considerations.

# Creation of Youth Advisory Liaison to City Council

# BACKGROUND

The City Council finds and declares the following:

- A. Integrating the voice of youth within governmental processes serves the best interests of not only youth, but the also the larger Sacramento community of which they are a part.
- B. The City Council recognizes the importance of elevating and integrating the voice of youth between the ages of 18 and 24, in the City of Sacramento's policymaking process.
- C. As part of its ongoing commitment to supporting youth within the City of Sacramento, the City Council established the Sacramento Youth Commission (SYC) in 2019. (Ord. 2019-0010.) The SYC provides a means to engage community youth while providing them with a platform for their opinions and advice.
- D. On August 31, 2022, the City Council directed staff to research the viability of a youth advisory position to the Sacramento City Council, to further explore ways to empower community youth and bring the voice of youth to Council discussions.
- E. The City Council now hereby seeks to create a position that that will further elevate the voice of the City's youth by providing a high profile, transparent, and direct channel between youth and the City Council.

# BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

Section 1: The City Council directs the City Manager to establish the position of Youth Advisory Liaison to the City Council, within the Office of Youth Development, to serve a term of 2 years from the date of appointment.

Section 2: The Youth Advisory Liaison shall:

- A. Attend regularly scheduled City Council meetings, except closed sessions or quasi-judicial proceedings, to be available to City Council to provide advice on any matters relating to youth;
- B. Have a designated seat at the dais;

- C. Receive the City Council agenda at the same time such material is provided to Councilmembers; and
- D. Be invited to attend staff briefings offered to Councilmembers, except those briefings relating to closed session, quasi-judicial proceedings, personnel or labor matters, or any matters that are otherwise privileged.

Section 3: The Youth Advisory Liaison shall present a report to the Sacramento Youth Commission, on matters presented to City Council related to youth, no less than once per calendar year. Nothing in this resolution shall prohibit the Youth Advisory Liaison from presenting to the Sacramento Youth Commission with greater frequency.

Section 4: The City Council directs staff to review and make recommendations to the City Council regarding potential staffing support for, and a stipend to, the Youth Advisory Liaison.

Section 5: The City Council shall establish the process by which the Youth Advisory Liaison will participate during City Council Meetings.

Section 6: The City Council directs the City Manager's Office to establish a selection process similar to the process for selecting City commissioners and which shall include a role for the Sacramento Youth Commission.

Section 7: Applicants for the Youth Advisory Liaison position must be between the ages of 18-24 at the time of appointment, and have experience with at least one of the following criteria:

- A. Participating in a youth leadership program sponsored by the City of Sacramento, the County of Sacramento or a Joint Powers Authority located within the County of Sacramento;
- B. Participating in a leadership skill-building program, through a multisession curriculum, presented by a community-based organization located within the City of Sacramento; or
- C. Attending and making public comment at a minimum of 3 Sacramento Youth Commission or 3 Sacramento City Council meetings, within the 12 months prior to appointment.



# Proposal for Youth Advisory Seat on City Council

The City of Sacramento is poised to make history by creating a youth advisory seat on its City Council and recognizing the importance of youth voice in policymaking. A cursory review of the City Councils in 8 major cities across the nation (New York, Boston, Philadelphia, Washington DC, Miami, Dallas, Chicago, Los Angeles) revealed that none have a youth-designated seat on their legislative body. In the Sacramento region, the only governing bodies that have a youth member are the school districts. Four of the 7 districts serving Sacramento youth have student members on their Boards of Education.

Recommendations for the youth seat on City Council are as follows:

#### Term

2 years

## Type of Seat

- Preferential voting seat on all matters except closed session with
- Preferential voting defined as formal expression of opinion that is recorded in the meeting minutes and cast before the official Council vote
- Preferential vote shall not affect the final numerical outcome of City Council vote.

#### Rights

- Attendance all council meetings except closed session
- Seated with councilmembers on dais
- Receive all materials at the same time they are presented to Council except those related to closed session as well as all materials between meetings except those for closed session
- Invited to staff briefings or provided with separate briefing within same timeframe as other Councilmembers

## **Other Considerations**

- Considered a member of a legislative body for purposes of Brown Act
- Not liable for any acts of Council
- Shall not be counted in vote to carry any motion or whether a quorum is present
- Elimination of seat only possible through Council approved resolution

## Compensation

- For time in trainings, meeting preparation, meeting attendance and Council-related activities
- For mileage

# **Eligibility to Apply**

- Be a citizen of the United States and a resident of the State of California
- Be a registered voter and a resident within the City of Sacramento not less than 30 days
- Be between ages 18-24 at time of swearing in
- Participation in:
  - Youth leadership program sponsored by the City of Sacramento, County of Sacramento, JPA, or community-based organization with program providing leadership skill-building through a multi-session curriculum; and/or
  - Attendance and public comment at 3-4 Sacramento Youth Commission meetings and/or
  - Attendance and public comment at 3-4 Sacramento City Council meetings

## **Selection Process**

- Application created by City Clerk and Sacramento Youth Commission (SYC)
- Application submission to City Clerk
- Upon closing of application period, SYC reviews applications and recommends up to 5 candidates to P&PE
- P&PE makes recommendation to Council
- Council approves

## Outreach

- Must involve Sacramento Youth Commission
- Conducted through
  - City-operated youth-serving programs
  - o CBOs
  - o All high schools in school districts serving Sacramento youth
  - o SETA
  - o SCOE
  - Community college system
  - o CSUS

## **Training and Support**

- Initial orientation by City Clerk to build knowledge of City Council and to understand responsibilities and expectations
- One City staff assigned as "supervisor" for individual
- Ongoing support prior to each Council meeting provided by a Council office (Councilmember or staff) by reviewing agenda with and answering questions from youth member
- Responsibility for ongoing support rotates every two months starting with District 1 through District 8 and ending with Mayor's office then rotation repeats

# **Estimated Time Commitment**

- Preparation for meetings: 4-5 hours/week
- Meeting attendance: 4-5 hours/week
- Training/support: 1-2 hours/week
- Other Council-related activities: 0.5-1 hour/week
- Total estimated time: 9.5 13 hours/week
